

PROJECT DESCRIPTION/PETITIONER

Renita Addison is a licensed cosmetologist with an existing clientele desiring to relocate her business to Berkeley. She believes Berkeley is right place to continue to promote her hair care business.

Site Location: 8557 Airport Rd, Berkeley, Missouri 63134 (St. Louis County locator #11K341442) such property containing approximately 0.46 acres. The space is approximately 1370 square feet (250 sq. ft., seating and 1120 sq. ft. open space salon setup). The strip mall is 6,750 sq., ft. under roof, and has approximately 48 shared parking spaces with the existing Cleaners, a clothing boutique, and a health food store.

PLAN COMMISSION RECOMMENDATIONS:

The Plan Commission recommends approval to the City Council to consider and approve the Special Use Permit for Renita Addison to operate a hair salon with conditions at 8557 Airport Rd.

The following conditions are recommended as a condition of approval from **Public Hearing to be held by the City Council on Case No. 16-13 – 8557 Airport Rd. (Hair Salon)**

1. Hours 6am – 1am, Sunday – Saturday and some holidays
2. Petitioner shall comply with State Licensing for Cosmetologist
3. Petitioner shall comply with designed occupancy load as set by Fire Marshall
4. This site shall comply with all the applicable regulations pertaining to health and safety for vehicular and pedestrian traffic, zoning, building, sign codes, fire and safety protection standards as required by the City Fire Department, City of Berkeley and St. Louis County. Commercial Occupancy Inspection is required.
5. The area shall be maintained and kept free and clear of any debris or trash or weeds. All plants/trees/bushes and landscaped material will be properly maintained along Airport Rd
6. The Special Use Permit take effect upon the approval by City Council.
7. Hours of operation as identified by Petitioner are (7 days a week) Sunday – Saturday 6am -1am, and some holidays; due to customers with special needs.
8. Business signage shall be limited to no more than 10% of window space. The petitioner will be permitted one exterior wall mounted sign at the front of the business.
9. The special use permit is non-transferable – and shall not exceed 10 years.


